- 1. The premises i.e Dinning hall size 47' x 39' = 1833 Sqft, Kitchen room size of 17'.9" x 10'.8" = 176 Sqft and Store room size of 18'.9"x 10'.6" = 184.5 Sqft, Total area 2193.5 Sqft including of 6 nos. 2 Ton Blue Star make split A.C,14 Nos. USHA make wall fan,3 nos. USHA Make celling fan and 2 nos. Exhaust fan will be licensed out for running of A/C Restaurant only.
- 2. The bidder shall strictly quote annual license fees excluding GST/taxes.
- 3. Licence fees shall be increased @10% each year with GST as applicable.
- 4. A security money of Rs. 15,00,000 /-(Fifteen lakhs)only as fixed shall be deposited by the successful tenderer.
- 5. The licensee has to execute an agreement with the OSRTC within seven days of being selected through Tender or else the EMD amount will be forfeited.
- 6. The span of lease period shall be counted from the date of execution of possession/agreement between two parties.
- 7. The licencee has to pay electricity charges as per meter reading at commercial tariff.
- 8. The licensee shall not be allowed to do any other business in the premises other than for which it has been given through tender.
- 9. No firewood cooking shall be allowed in the A/C Restaurant.
- 10. Alcohol/ intoxicating and smoking items are strictly prohibited for sale or use.
- 11. The licencee will ensure that the environment, landscape, flora and fauna and other local features of A/C Restaurant is not disturbed and damaged. The licensee shall take necessary steps to avoid environmental pollution, noise pollution. Use of plastic poly bags is totally banned.
- 12. The licencee shall not use any portion of the building other than the area leased out for the purpose.
- 13. The licencee shall not sublet the building whole or part thereof.
- 14. The licencee is strictly prohibited to make any alteration, modification of the premises.
- **15.** He shall obtain food licence from competent authority before start functioning of restaurant.
- 16. Display of rate chart of the product is mandatory for appraisal of customers.

- 17. The authority may rescind the agreement at any time for violation of any of these terms and condition.
- 18. He has to pay all Govt. taxes as applicable and file necessary clearance as applicable.
- He will follow all such regulation and laws of the Government which will be force in time to time.
- 20. The tender papers can be obtained from the Accounts Officer, OSRTC, Paribahan Bhawan, A.G Squre Bhubaneswar/Office of the DTM (A),Badambadi, Cuttack from 6 /7/2019 to 23/7/2019 during office hours on payment of 2360/- (2000/-+18%GST) (Non refundable) in shape of cash.
- 21. The complete sealed tender as per proforma enclosed shall be dropped in the Tender Box kept in the Tender Room at Corporate Office, OSRTC, Bhubaneswar or by Registered/Speed Post so as to reach the Office of the Corporate Office OSRTC, Bhubaneswar on or before 230 7 2019 up to 3 .00 P.M. after which no tender will be received and the sealed tenders will be opened on 23. 7 .2019 at 9 .00 P.M. OSRTC shall not be held responsible for any postal delay.
- 22. The full amount of EMD & security in shape of Bank Draft to be submitted as per tender schedule at the time of submission of tender paper failing which the tender paper shall be treated as cancelled.
- 23. An agreement shall be executed in the manner as prescribed by the OSRTC reserving the right of OSRTC to alter/ amend the condition of agreement at any time without assigning any reason thereof.
- 24. The G.S.T. as applicable will be levied on such yearly license fees to be paid by such licencee.
- 25. No tender form will be considered unless it is accompanied with cash receipt/bank draft against payment of Tender paper cost, earnest money and security money as indicated above.
- 26. The tenderer is to produce an affidavit to the effect that there is no criminal case against him/her .On being successful bidder he/she is to produce the said certificate from the local I.I.C. of the P.S. concerned before signing the agreement. In case of failure in this case his/her application shall be summarily be rejected & the EMD shall also be forfeited.
- 27. The authority reserves the right to reject/accept any or all the tenders without assigning any reason thereof.
- 28. In case of default in payment of yearly license fees by 1<sup>st</sup> month of every succeeding year, interest @ 18% compoundable shall be charged

- against the outstanding payment and non deposit of yearly license fee within 3 months will entail cancellation of license.
- 29. The licensee is not involved in any legal complicacy with OSRTC prior to take part in tender.
- 30. After finalization of tender, the allotment order will be issued in favour of successful tenderer within 7 days from the date of finalization of tender to take over the physical possession of the A/C Restaurant.
- 31. In case of any dispute arising out of such tender the same shall be referred to the Chairman-cum-Managing Director, OSRTC whose decision shall be final and binding.
- 32. In case of the price quoted in the tender is not up to the expectation of the authority or tender is defective or no tender or limited tender is received in this regard, the corporation reserves its right to cancel the tender or finalize the selection through negotiation.
- 33. The allotment in favour of successful tenderer can be terminated at any point of time by the OSRTC by giving one month notice.
- 34. The allotment of A/C Restaurant of OSRTC shall be only for 03 years .lt may be extended beyond 03 years if necessary through fresh agreement.
- 35. In case OSRTC A/C Restaurant is decided to be developed for any other purpose, the licensee has to vacate the area on receipt of one month Notice from OSRTC.
- **36.** No permanent construction or alternation of existing structure is allowed to the Licencee. In case any temporary construction required it must be prior approval of the authority of OSRTC.
- 37. The security amount and EMD amount deposited by the successful tenderer at OSRTC bears no interest and under no circumstances the tenderer shall claim the interest.
- 38. The licensee shall not use the land in the premises of OSRTC for any purpose other than as mentioned in the tender notice and no illegal activities shall be carried out there and if detected the licensee shall be responsible and penalized as per law.
- 39. The licencee shall install the power and water connection, as per requirement in the premises of OSRTC by his/her own cost and shall pay the necessary charges to the concerned authority regularly. The OSRTC shall not take any responsibility in this regard. Failure to deposit these charges in time shall lead to cancellation of allotment.
- 40. The Dumping of wastage/garbage without cleaning the same daily and causing unhygienic situation shall entail cancellation of the licence

without giving prior intimation along with forfeiture of the security deposit. The licensee shall make his/her own arrangement for shifting of the organic and other waste daily .He/she shall keep the area neat and clean.

- 41. He has to submit no due certificate from the OSRTC.
- **42.** There is no moratorium period shall be given for running of Restaurant. It is allotted on "as is where is basis".
- **43.** The security deposit and EMD amount shall be refunded to the unsuccessful bidders immediately after completion of tender process.
- 44. The terms & Conditions of this tender paper is part of the agreement and be enforceable at the time of any dispute and to be sued before the Court of law under the jurisdiction of Bhubaneswar Court & High Court of Orissa, Cuttack.
- **45.** The details of terms and conditions will be stipulated in the agreement to be signed by both the parties.
- 46. After execution of agreement if the successful tenderer fails to take physical possession of allotted land, the EMD will be forfeited and license fees due till the date of cancellation will be realized from security deposit.
- 47. The previous allottees must vacate the area after finalization of tender process and if any temporary construction noticed the same will be demolished by authority without making any correspondence or intimation. No representation will be entertained to that effect.
- 48. Pan No. is mandatory and should be mentioned.GST No. if not available at the time of submission of application ,the same is also mandatory to be submitted to OSRTC after qualifying as successful tender.
