TERMS AND CONDITIONS OF TENDER FOR LEASE OF VACANT ROOMS AT OSRTC BUS STAND, BADAMBADI, CUTTACK VIDE TENDER NOTICE NO. 3816 DT.53-79

- License shall be issued for lease of open Rooms at Badambadi, Cuttack as mentioned in the aforesaid tender notice to individual person/Body Corporate/Company for a period of three years as mentioned in the tender notice.
- 2. The complete sealed tender papers as per the proforma enclosed, along with other required papers/documents can be dropped in the tender box kept in the tender room of OSRTC Corporate Office, Bhubaneswar or through Registered/Speed post only so as to reach at Corporate Office, OSRTC, Bhubaneswar, on or before 23/7/2019 up to 3.00 PM. after which no tender papers shall be received. The sealed tenders shall be opened on 25/7/2019 at 4.00 PM.
- 3. Envelope containing the tender papers must be super scribed "TENDER FOR LEASE OF VACANT ROOMS AT BADAMBADI BUS STAND, CUTTACK".
- 4. The full amount of security in shape of Bank Draft of Rs.03,00,000/-(Rupees Three lakhs)only & EMD amount of Rs.10,000/-(Rupees Ten thousand)only are to be submitted at the time of submission of Tender papers by the tenderer ,failing which the tender paper shall be treated as rejected. The Security/EMD amount so deposited shall carry no interest.
- 5. An agreement shall be executed by the selected bidder in the manner as prescribed by the OSRTC reserving the right of OSRTC to alter and to amend the condition of agreement at any time considered expedient.
- 6. Both the parties are at liberty to terminate the contract by giving one month notice duly served on the other party.
- The selected bidder shall have the right of preference in the matter of renewal after successful completion of period of agreement, subject to terms and conditions mutually accepted.

- 8. Service tax/G.S.T. as applicable shall be levied on such rent monthly to be paid by such allottee.
- In case of default in payment of rent by 7th of every month interest @ 18% shall be charged.
- 10. The agreement may be renewed after completion of agreement period subject to satisfaction of performance of the licensee by the licensor with enhancement of 20% to the previous agreement amount.
- 11.No tender form shall be taken into consideration unless it is accompanied with bank draft against payment of earnest money and security deposit as indicated above. The I.T.C.C. or non-assessment certificate and two passport size photographs have to be enclosed to the tender form failing which the tender is liable for rejection.
- 12.NDC with reference to the firms having business with OSRTC earlier are supposed to be enclosed in shape of a No Due Certificate from the Corporate Office of OSRTC. New firms coming for business to OSRTC for the first time, should furnish a certificate/declaration that no business transaction with OSRTC has been done earlier.
- 13. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 14. In case of any dispute arising out of such tender, the same shall be referred to the Chairman-cum-Managing Director, OSRTC whose decision shall be final and binding.
- 15.In case of the price quoted in the tender is not up to the expectation of the authority or tender is defective or no tender or limited tender is received in this regard, the Corporation reserves it's right to cancel the tender or finalize the selection through negotiation.
- 16. The allotment in favour of successful allottee can be terminated at any point of time by the OSRTC by giving one month notice.
- 17. The allotment of Room shall be only for three years. It may be extended beyond three years, if necessary, depending on the situation at the time of completion of **03** years.

- 18. That, in the event of the default in payment of monthly rent for more than two months, it will be realized from the security amount deposited by the licensee and the license shall be cancelled.
- 19. Any legal case or disputed claim arising out of activity of the licensee, shall be the sole responsibility of the licensee. OSRTC shall not be responsible for it.
- 20.In case Badambadi Bus Stand is decided to be redeveloped into Interstate Bus Terminal or any other purpose, the allottee has to vacate the area on receipt of one month notice as the area is purely earmarked for temporary bus stand and OSRTC will take over responsibility.
- 21. Any addition/alternation/temporary construction noticed, the same will be demolished by the authority of OSRTC without making any correspondence or intimation. No representation will be entertained to that effect.
- 22. The licensee shall install the power and water connection if any as per requirement of the shop room at his/her own cost and shall pay the necessary charges to the concerned authority regularly. The Corporation shall not take any responsibility in this regard. Failure to deposit these charges in time shall lead to cancellation of allotment.
- 23. The security deposit of Rs.03,00,000/-(Rupees Three lakhs) only and EMD amount Rs.10,000/-(Rupees Ten thousand) only shall be refunded to the unsuccessful bidders immediately after completion of tender process.
