**TERMS AND CONDITIONS OF TENDER FOR LEASE OF LAND OF AC.2.045
BELONGING TO OSRTC, A.T.M.'S OFFICE PREMISES AT J.K.ROAD VIDE TENDER
NOTICE NO. _____ DT _____**

01. Allotment of land in the premises of OSRTC A.T.M.'s Office, J.K.Road as mentioned in the aforesaid tender notice will be licensed to individual person/Body Corporate/company for a period as mentioned in the tender notice.
02. The complete sealed tender as per proforma enclosed shall be dropped in the Tender Box kept in the Tender Room at Corporate Office, OSRTC, Bhubaneswar or by Registered/Speed Post so as to reach the Office of the Corporate Office OSRTC, Bhubaneswar on or before **17 .08. 2018 up to 3.00 P.M.** after which no tender will be received and the sealed tenders will be opened on **17 . 08.2018 at 4.00 P.M.** OSRTC shall not be held responsible for any postal delay.
03. Envelope of the sealed tender must be superscribed "Tender for license of land in the premises of OSRTC, A.T.M.'s Office J.K.Road."
04. The full amount of EMD & security in shape of Bank Draft to be submitted as per tender schedule (Column 4 and 5) at the time of submission of tender paper failing which the tender paper shall be treated as cancelled.
05. An agreement shall be executed in the manner as prescribed by the OSRTC reserving the right of OSRTC to alter/ amend the condition of agreement at any time without assigning any reason thereof.
06. Service tax/G.S.T. as applicable will be levied on such monthly rent to be paid by such allottee.
07. Monthly rent shall be enhanced by 20% every 03 years.
08. No tender form will be considered unless it is accompanied with cash receipt/bank draft against payment of earnest money and security money as indicated above. The I.T.C.C. or non-assessment certificate and two passport size photographs have to be enclosed to the tender form failing which the tender is liable for rejection.
09. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
10. In case of default in payment of monthly rent by 7th of every succeeding month, interest @ 18% shall be charged.
11. After finalization of tender, allotment order will be issued in favour of successful tenderer within one month from the date of finalization of tender to take over the physical possession of the room as applied for.

12. In case of any dispute arising out of such tender the same shall be referred to the Chairman-cum-Managing Director, OSRTC whose decision shall be final and binding.
13. In case of the price quoted in the tender is not up to the expectation of the authority or tender is defective or no tender or limited tender is received in this regard, the corporation reserves its right to cancel the tender or finalize the selection through negotiation.
14. The allotment in favour of successful allottee can be terminated at any point of time by the OSRTC by giving one month notice.
15. The allotment of space in the premises of OSRTC A.T.M.'s office, J.K.Road shall be only for 10 years .It may be extended beyond 10 years if necessary.
16. In case OSRTC J.K.Road land is decided to be developed for any other purpose, the allottee has to vacate the area on receipt of one month Notice from OSRTC as the area is purely earmarked for temporary bus stand and OSRTC will take over responsibility.
17. If any temporary construction noticed, the same will be demolished by the authority without making any correspondence or intimation. No representation will be entertained to that affect.
18. The security amount of **Rs.20,00,000/- (Rupees Twenty lakhs)** only and EMD amount of **Rs.50,000/- (Rupees Fifty thousand)** only deposited by the successful tenderer at OSRTC bears no interest and under no circumstances the tenderer shall claim the interest.
19. The successful tenderer shall execute an agreement within 7(seven) days from date of intimation from OSRTC.
20. The allottee shall not use the land in the premises of OSRTC A.T.M.'s Office at J.K.Road for any purpose other than the purpose as mentioned in the tender notice and no illegal activities shall be carried out there.
21. That, in the event of default in payment of monthly rent for more than two months, it shall be realized from the security amount deposited by the licensee and that will be recouped by the licensee in the next month, otherwise the license shall be cancelled.
22. The licensee shall install the power and water connection, if any, as per requirement at the site of the land in the premises of OSRTC J.K.Road his/her own cost and shall pay the necessary charges to the concerned authority regularly. Corporation shall not take any responsibility in this regard. Failure to deposit these charges in time shall lead to cancellation of lease.

23. Dumping of wastage/garbage without cleaning the same daily and causing unhygienic situation shall entail cancellation of the lease without giving prior intimation along with forfeiture of the security deposit. The licensee shall make his/her own arrangement for shifting of the organic and other waste daily. He/she shall keep the area neat and clean.

24. The security deposit of Rs. 20,00,000/- (Rupees Twenty lakhs) only and EMD amount of Rs. 50,000/- (Rupees Fifty thousand) only shall be refunded to the unsuccessful bidders immediately after completion of tender process.

25. Any illegal issue or dispute arising out of the activities of the licensee shall be the sole responsibility of the licensee. OSRTC shall not be held responsible to that effect.

26. Details of terms and conditions will be stipulated in the agreement to be signed by both the parties.

27. After execution of agreement of the successful tenderer fails to take physical possession of allotted land the EMD will be forfeited and rent due till the date of cancellation will be realized from security deposit.

4. In case of any dispute between the O.S.R.T.C and the executants(s), same shall be resolved by way of reference of the matter to an arbitrator of OSRTC whose decision shall be final and binding on me.
